

November 8, 11, 2021 Immediately Following the Public Hearing Council Meeting.

1. <u>Quorum</u>

2. Public Hearing

Mayor Svenson called the public hearing to order at 6:00 pm.

Robert Webster explains that the public hearing is for grading only and nothing else. This is the SEPA for the development but all they are doing is the early grading and putting in utilities. They have signed a letter of risk of acknowledgment so if it does not get approved by the hearing examiner then whatever they put into it is their loss. This is the development going in on the five (5) acres behind Guadalajara near the water towers.

Mike McDonald is the first to speak with a few questions. He wanted to clarify if the SEPA was for the entire project, or if there would be another application for the rest of the project. Robert explains that it is for the whole development project. Mike's 2nd question was if the whole project would be going before the hearing examiner. Robert says that is correct. Mike asked if this was a multi-level development. Robert says that it is an apartment complex. Mike was concerned with the annexation of property. Robert replied that there is no annexation currently. The fee schedule for the utility fees outside the city was brought up. Concerns of it being doubled were expressed. Council member Lonnie Dowell says that does not happen. Mike references an epiphany of the annexation of the UGA. Mayor Svenson says that the city is currently working on that, and it will be going in front of the boundary review board as soon as it is ready. Mike asks if he has an idea on how long that process will be.

it will be ready for review next year. Mike talks about other areas, the completion of a project in a UGA, would come with an annexation of the property into the city as part of the final approval, and asks the council to consider this in the meantime. Mayor Svenson says that they would prefer to focus on annexing the whole UGA at one time rather than individual pieces at a time. Mike explains that it is a very streamlined process to get a new development annexed at which point the city could benefit from the revenue of that section. Council member Dowell states that his understanding is that an annexation must be continuous. In other words, it cannot be city, UGA, city etc. Mike notes that the parcel in question would be continuous on both sides. Mikes next question was about the density of the project. He worries that there may be some issues with stormwater and retention. Mike brought up some other things that Robert explains is all on the deficiency letter.

Back about the UGA annexation, the city attorney, Robert, and Svenson, explain that because the processes are so long, and the boundary board meets only at certain time; therefore, the city would like to do the entire UGA at one time.

The next speaker was Patty Maninfor. She owns property in Winlock and some buildings. She talks about when she tried to annex a piece of property and all the drama that it caused. She explains that eventually she did get the annexation. She says that now she can understand the time it takes to get an annexation, but she is not sure about how the city is going about it. She says that to do that, 80% of the people in that area will have to agree. Moving on, Patty says that she is not happy about the engineer taking 95% of the ground cover on this piece near her property. She says that in the wet season it will be a wet muddy mess. She talks about there needs to be a 24 hour watch to make sure things do not get out of control with the water during the wet season. She also questions the part in the plans how a portion of her property would be dedicated to city street and that no one has contacted her about that. She knows that the property behind her can use the current road which is gravel and used by the city to get to the water tower. She currently has it gated off and she will be able to keep it gated so she does not know how that will be for an apartment complex. She says maybe something like that can be worked out in the future. Patty would like to slow down a bit because some things need to be worked out. Robert asks Patty if the engineer talked to her about the road to her property. Patty replied that she contacted him about it, and that no one had previously attempted to contact her. Robert says that she contacted him, and then he contacted Travis who said that he would call her. He wanted to make sure that he called her like he said he was going to, and Patty replied that yes, he did after the fact in late September. It was misunderstood that the road was a city easement. She reiterates that the road is an easement, but it is not a city easement. Patty's final statement was that sometimes things need to slow down a little bit so that everyone can see what's going on.

Mayor Svenson asks if there is anyone on the phone line. There was not. There was no one else in the audience. Mayor **Svenson closed the public hearing at 6:34 pm.**

3. Call to Order of Regular Meeting

Mayor Svenson called the regular meeting to order at 6:34 pm.

The timber is very small and there is a lot of underbrush. The man who looked at it said in his lifetime, that timber would never be marketable. Svenson does not know yet what it would cost to thin the timber, and in what year the city would be able to harvest. He is looking for a person give a quote on that.

8. Mayor Comments

Brandon Svenson thanked the community for all the support for everyone in the election that just passed.

9. Council Comments

Eric Contreras said that they put on the Halloween festival at the community building, and it was a success. They had around 600 people show up, the kids had a wonderful time. Everyone was happy, and it coincided with the trunk or treat which also did well. He thanked everyone who helped. All the kids from the high school and middle school who pretty much ran all the booths. It was great for the community, and it was good to see everyone out having a good time.

Council member Lindsey Alvord said that she was surprised at how many people came out and was excited about it.

Mayor Svenson said that he loved seeing the families come out and do things together again. He then gave a shout out to the Winlock football team who are going to state. Eric Contreras said a congratulations to player Nolan Swafford for breaking state records.

11. <u>Agenda</u>

a. Impact Fees Discussion, Travis Goddardt, City of Woodland

Travis addresses the council by thanking them for inviting him to speak. He is community development director, the deputy clerk treasurer, and the public records official for the city of Woodland. He talks about Woodland to help highlight the similarities as far as fast growth between Woodland and Winlock. Woodland is on the edge of Clark and Cowlitz county with Lewis River to the east and the Columbia River to the west. They are bisected by the railroad as well. There is a significant amount of

un-zoned land, and a lot of industrial growth. Most of the growth in Woodland is commercial and industrial stuff. His city has a lot of transportation challenges.

Travis talks about impact fees for parks, transportation, and fire department. He goes over his formula for Woodland's school, parks, and transportation impact fees as an example with the council to help explain how they handled their fees. It is important to get an engineer involved in the preparation and planning.

Travis goes over some different ways to get developers to pay for things like sections of sidewalks by using defensible reasons like, the developer's development will have children living there who will be walking to the school down the street. There are no sidewalks currently in place and that would be unsafe for children to walk from his development to the school. Or a scenario where a new development with 50 houses is projected to have 30 new students attend the school the following year. A portable classroom can hold 35 children and costs around \$35,000. That should be an ask. These are just two examples of impact fees and why the city should be working with them and doing studies. The city has options like hiring consultants, holding public hearings, and inviting developers to attend, or adopting resolutions that say that each house will generate X number of kids after running the calculations. Travis tresses having everything calculated so when a developer comes to the city wanting to build, the city can be firm in that if they want to build, they need to pay the fees based off the size of their development.

Council member Dowell asks what would happen in the scenario where the school board does not want to co-operate. Is there a way that the city could go ahead and do the calculations on their behalf, The long answer was yes, and Travis explains completely how the city could do this and keep things moving.

b. Resolution 2021-10 – Surplus Guns and Ammo

A resolution of the City of Winlock, Washington, Declaring Personal Property of the City of Winlock to be surplus and of no further use to the City.

Chief Valentine says that recent legislation has made it illegal for officers to carry anything over 50 calibers. They are currently in possession of one (1) Remington Magnum Wingmaster, one (1) Remington 870 Magnum 12-gauge shotgun, (441) 12-gauge shotgun shells, and (34), 12-gauge bean bag rounds. The resolution says there are (30) bean bag rounds, but Valentine explains that it is actually (34).

Valentine explains that he does not want them in the department anymore, and if the legislation changes again to allow these again, these are not the shells or guns that they will want to use anyway and would be purchasing something else.

Council member Lonnie Dowell motions to approve Resolution 2021-10 with the modification (34 bean bag rounds) Council member Jeramy Allman 2nd. Passed unanimously.
