# b. Jackson Civil, Development Code Update Agreement

# c. Winlock Park Board – Kirsten Stalnaker Pursuing Grant Funds

Recreation and Conservation Office (RCO), who offers the grants that the board is pursuing is requiring the park board to have official approval from the mayor, council, and planning commission before moving forward with the application process. Kirsten is hoping for approval from council and asks if they have any questions or concerns regarding what they have thus far. Council liked the plan. #### **Request funds for New Mower**

Kirsten said if that was the case, it would work, but it would be very tight.
