AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Winlock from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement – public works
- Compliance with public works projects – prevailing wages and change orders
- Accounts payable – general disbursements
- Utilities – adjustments
- Financial condition and fiscal sustainability
- Open public meetings – documentation of minutes and executive sessions

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. That report includes a federal finding regarding a lack of internal controls related to Davis-Bacon Act (prevailing wage) requirements. INFORMATION ABOUT THE CITY

The City of Winlock serves approximately 1,340 citizens in Lewis County. The City provides a full range of services including street maintenance and construction, judicial, law enforcement, and general administration services. In addition, the City owns and operates water, storm water and sewer systems.

The City is administered by a mayor-council form of government with an elected, five-member Council and an independently elected Mayor. The Mayor appoints Clerk/Treasurer and Chief of Police to oversee the City's daily operations as well as its seven full-time employees and four part-time employees. For fiscal year 2018, the City had operating expenditures of \$1,376,120.
