

CITIZEN/NUISANCE COMPLAINT FORM

Guidelines:

- Don't assume that a complaint has already been made by someone else.
- When you call city hall, give your name, address, and phone number. This information is kept confidential but is necessary in case an inspector needs to contact you for further information.
- Give the physical address where the nuisance is located and list specifically what is the issue. The city needs specific complaint details. Be accurate and factual.
- Give the city time to act. Housing code violations, for example, can take longer to correct. Contact city hall after a reasonable amount of time has passed to find out the progress on the complaint.
- Contact city hall if the issue reaccurs or if a new issue occurs.
