Mayor Brandon Svenson sent a shout out to the high school football team. It was a very good season. He enjoyed watching them and everyone is proud of them.

6. Council Comments

Lonnie Dowell asked about Toledo Tel bringing in fiberoptics into Winlock. The last he heard was that the accepting of the grant stage was where things were at currently. Svenson said that was correct and that he has not heard any more on it. He is planning to speak with the director this week.

7. Committee Reports

a. Finance

Council member Allman says that sales and use taxes are up a lot compared to previous. Still working on updating property taxes.

Brandon says that he spoke with Amy Buzzard and that she will be helping the city with grant writing.

Parks chairwoman Kirsten was in the audience and let the council know that she did not get any committee information to Lindsey for this meeting.

8. Staff Reports

a. Water/Sewer – Rodney Cecil

Rodney went over number 4, project updates with the council. They are trying to consolidate all the wells into 2 well, and all the water rights will be pulled out of all locations at any time.

Mickelson will be giving the city 2 wells and Rodney is working on getting a 3rd. He will be coming to the council later for funds for this as time goes on. There were no questions.

b. Liquor Control Board - Penny Jo

Penny Jo did not have the papers in front of her stating what 2 businesses are up for their license. One was Guadalajara and she believes the other is Franks Hideaway. There were no concerns from the council.

9. Public Comment

Randy Pennington addressed the council. The fire station was able to bring on 1 new person per shift in a paid position.

Randy also informs the council that after 37 years, he will be retiring in 10 days. He will still be a commissioned officer, but his patrol duties will be done. Randy spoke on his sense of gratitude that he has for the city of Winlock for his career as a police officer. In 1985 he was a paramedic and a fire officer in Tacoma. At that time, he was a 911 supervisor. A police officer came to his office one day and said, "You're pretty good with fire and EMS but you don't know diddly squat about being a cop" That same officer sponsored him so that he could go to a reserve academy so that he could learn about being an officer — being a cop. After he graduated, he was recruited into Napavine before moving to Toledo. The officer that came into his office that day and told him that he needed to get into the academy was Chief McPherson from Winlock WA. Randy went on to say that he has worked with many fine officers from Winlock including the 3 officers working today in Winlock. Randy also

told the council about how in Toledo he found himself in dangerous confrontations and twice, it was a Winlock cop who came up at those times and had his back.

11. Agenda

a. TIB UCES (Added from agenda)

Jon Hinton was on the phone and spoke with council. There are two cost estimates for two different schedules for the entire project on the close out of First St. There is an additional \$138,000 "and change" for TIB to pay. Hinton says that there will be a total reimbursement of a little over one million dollars. There is no guarantee that they are going to pay %100 of that until it is in front of the TIB commissioners. Winlock's participation in that amount would be \$7,202.10. Hinton's request is to allow the mayor to sign and date these so that Hinton can send into TIB and hopefully pay the city of Winlock \$38,000. There were not questions.

b. Jones Road Update - Sheets Logging

Boone from Sheets Logging was on the phone with the council and advises them on the timber that is on the 40 acres that the city owns on Jones Road. This is the section of land that Mayor Svenson would like to sell and use the money as a grant match for the parks in Winlock.

Boone believes that there is too much stuff that needs to be done to it. It is overgrown and he does not see any marketable timber on it. Its rugged ground that would require roads being built into it which at that point would start getting to be expensive. There is also a lot of younger stuff growing in it like maple and alders that would need to be PCT'd (pre-commercial thinned) to get the stand to be where it needs to be to grow properly. The timber remaining is only about 10-20 years old and for the next 30 years there would need to be even more money put into it per acre to make sure it grows properly to harvest. Overall, his opinion is that this would be an expensive project for what they want to do with it.

Brandon did get a second opinion from another tree company prior to the meeting who said pretty much the same thing. He tells the council that they don't have to make any decisions right now. It is an expensive project, and it would be banking on that anyone else as mayor and council over the next 30 years would take care of it and, the possibility that logging in Washington State in 30 years may not be a thing with the way times are going. Brandon talks about selling the property as is and offering it to several of the local big timber companies to see who would have the highest bid. City Attorney Marissa Jay says that they could put it on the open market. It could be surplused, and then a real estate agent could be brought in. It would also need an appraisal. A commercial appraisal will cost a lot more than residential.

c. Fund Request for Excavator - Rodney Cecil

Rodney goes over the fund request with the council. He would like to pull money out of capital improvement for shoring and steel plates. Rodney would also like to get the excavator for deep digs over 20 feet that currently they are unable to dig down to with just the backhoe. The Kubota appears to be the best one for the best price. Brandon has talked with several people who own and use this kind of equipment and Kubota does come highly recommended. It is also capable of weed eating large areas, trimming trees up to 20 feet high, and pushing different large materials around with it. Most of

the work with it, however, will be for water and sewer. Currently sewer fixes are contracted out because Winlock does not have the machinery for it.

Rodney is also looking for \$5,000 dollars to put down for getting the water rights at Mikkelsen. There are also upgrades on various things that Rodney is requesting like radio meters.

In total he is looking for an approval of \$156,000 from capital improvement and \$126,000 from ARPA funds.
