5. Old Business

Council member Marty Poirrier said that he went to the school board and told them about the potential of impact fees. It is necessary that there be a qualified person or persons to oversee the inmates who will come to clean. She thanked Rodney Cecil and Marty Martin for getting the authorization to supervise. 12. Agenda

a. Award SR505 Sewer Extension Contract, Mike Marshall-Gibbs & Olson

Mike Marshall was present on the phone. He told council that he delayed the bid opening until Tuesday because of the snow. He says it was a tight grouping of seven (7) bids. He stated that the contractor chosen is a good contractor and that he has worked with them before. He recommends that the city award the contract and authorize the mayor to enter into the agreement when bonds and insurance are in, and the attorney concurs.

Svenson states that he would like things to go better this time, citing how things did not go so smooth last time with previous contractors. Councilor Poirrier asks Marshall what other projects he has worked with this contractor on. Marshall says that they have worked with the contractor on two (2) similar pump station projects for the city of Longview. It was rehabbing old pump stations. Council member Poirrier asks if those projects were completed with little to no issues. Marshalls says that he would not say there were little to none, but that there were no significant issues, that the contractor does not chase change orders, and are fair about what they are asking for. Council member Allman asks if there were any other questions and there were not.

Council member Jeramy Allman motions to accept the notice of award to Nutter Corporation of Vancouver Washington for the sewer extension to the industrial park and authorize the mayor to sign. Council member Anne Randt 2nd. Passed unanimously.

b. Hazardous Tree Removal – Winlolequa Park Bids

Park board chair Kirsten Stalnaker went over the bids with the council and suggested Petrich Tree Removal in the mid-range bid because of their ability to smoothly dismantle trees in a way that would not require falling any trees and therefore, the concern about park damage from falling trees can be avoided. She said the bid also includes cleanup. Council member Dowell asks if they will be chipping the wood and dumping the chips into the park. Stalnaker confirms. Council member Poirrier says that he agreed because he did not like the lack of detail in the invoice with Law of the Woods and that between the other two bids, Petrich had the better price. Council member Allman agreed, and Council member Dowell liked that Petrich had an invoice that says exactly what they plan to do

with the trees and the chips. Mayor Svenson states that they have been used in the past with good results.

There is an access road from SR505 already there, but it may need to be widened. There will be sidewalks down one (1) side, and a ditch on the other side of the road. The sewer will come down Kakela, and water will come off of SR505. Webster asks if there are any questions. Council member Dowell asks where exactly the entrance from SR505 will be. Webster responds that It will be across, and a little east across from Grand Prairie. Webster says that it has been run through Planning Commission. He does not see why sidewalks need to be put in on the other side of the road. Council agreed.

g. Water/Sewer Connection Fees

Robert Webster discusses the fact that Winlock's connection fees are lower than the other cities in the county. There are only so many connections. Once they are used that's it, and it would be good to make it worth it. Council member Poirrier asks Webster what is his suggestion? Webster says 4,500 for water and 5,500 for sewer. Mayor Svenson agrees and talks about all of the new connections that will put an added strain on the water treatment plant. None of those things are cheap and they all will cost money.

Robert talks about the citizens in the city limits paying 9,500 and for those outside the city limits are paying 7,500 hundred. Webster proposes that the entire UGA, all of Winlock, to pay the same for water sewer hookups. City council discusses the current fees, and those fees in comparison to those of similar and nearby cities. A few discrepancies between the verbal proposals, and those on paper, were discussed by council with Robert, and confirmations were established but council felt the paperwork presented needed to be clarified.
