Jim Buzzard, City Attorney for Winlock - City Attorney Informed the public that want to comment on Annexation that the public comment is not a debate. City Attorney Jim stated that what is happening is that a lot of people received a packet of information. Winlock is Annexing the UGA. The process for doing that is the City of Winlock has to submit notice to Annex to the County (The Boundary Review Board). That was done late September 2022. The way the process works. Once notice is submitted to the County the County will make sure that is legally sufficient, checking legal description and other information in the notice. Making sure that what is being asked to be annexed is an accurate description of real estate. That was deemed to be sufficient on November 28, 2022, and then there are two (2) more steps the Boundary Review Board assigns a file number to the notice of intent then the Boundary Review Board will collect a (\$50.00) filing fee from the City of Winlock. Once those three things are done. The (\$50.00) filing fee, file number, and the notice of intent is deemed legally sufficient is the effective filling date according to the Boundary Review Board, statute, and case law. By law across the state of Washington from that date December 1, 2022. That is when the (45) forty-five days starts. That (45) forty-five-day period past on January 15, 2023. Anybody within that (45) forty-five days can invoke the jurisdiction of the Boundary Review Board. If that happens then the Boundary Review Board then has the ability to follow through, denies, or modifies according to statue. For some reason, the (BRB) on January 12, informed the public and created their own (45) forty-five-day period that ended on February 27. Unfortunately, by doing so they waited until there was only (3) days left in the statutory period in which to invoke jurisdiction. (65) sixty-five citizens signed a petition asking for the BRB to review the Annexation. The board at County Commissioner also on February 27, asked (BRB) to invoke jurisdiction to review. According to State Law and (BRB) rules, that period had passed. By operation of law Annexation is deemed approved by the (BRB), because nobody acted, but since people invoked the (BRB). The (BRB) moved forward taking jurisdiction and setting hearings to review the Annexation. The City filed that the court deemed that the (BRB) deemed the Annexation approved by operation of law according to state law. Everybody who signed the petition and submitted it to the county is an interested party. You are all entitled to notice. That is why you received the packet in the mail. There is a lot of miss conception that the City of Winlock is suing the citizens and asking the citizens to pay attorney fees. Absolutely not correct, the City does not want to collect any fees from the citizens, but if the City did not give those citizens notice then that would be a problem. The petition specific action for (BRB) to not have any authority, because the (45 days) forty-five days has passed and is asking for it to be deemed approved by operation of law. Once that is over it has to come back to the City and be a public hearing, and an ordinance to be passed.
