4. Old Business

There was no old business discussed.

5. Mayor Comments

a) The Mayor thanked Tim White and Acts of Kindness for the flag contribution, they look fantastic and have had great comments.

b) He let Council know that we are gearing up for Egg Day and that Kenny is out there cleaning streets and hard at work to get ready. He said that any Councilor wishing to help assist with pressure washing, etc. is greatly appreciated.

6. Council Comments

- a) Councilor Allman stated that the new police vehicle is parked out front and noted that officer Chris is ecstatic and grateful for the new vehicle.
- b) Councilor Poirrier stated that he has had several people comment to him on the flags and the new cop car, and all comments have been overwhelmingly positive. We are moving in the right direction.

7. Committee Reports

- a) Finance Councilors Poirrier and Allman met with Penny Jo on April 22nd to review financial statements through March 2021. Councilor Allman stated that the budget tracking along well with a couple of departments under in revenue; however, confident with permits beginning to complete, and new bill cycle coming they will be on track. Expenditures are under control. Councilor Poirrier had nothing further to add.
- b) Grants Councilor Dowell stated there are two (2) grants we are looking at and is looking forward to seeing if new Engineer will have input and ideas. The Mayor noted that grant information came across his desk that he will pass on to the committee.
- c) Parks Councilor Randt presented the Park minutes from 4-5-21, noting highlights from the meeting, in particular getting bids for removal of more hazardous trees in Winolequa Park, park rental/reservation fees, park pictures and advertising and Egg Day plans.

8. Staff Reports

- a) Penny Jo She stated that before she presents her report, there are two (2) businesses: The Handy Store and Cedar Village that their liquor licenses are due to expire within the next ninety (90) days and asked if Council had opposition to their renewal that the Liquor Control Board should know. There was no opposition from the Council.
 - She presented her staff report for billing and there were no questions. Councilor Allman stated that he liked that the billing accounts receivable outstanding accounts weren't increasing and actually coming down.
- b) Robert Kurt Reddig just passed his sewer pressure tests up at Cedar Court and will be putting in waterlines soon and plans are to start building June 1st.
 - Red Rock is moving dirt and will be putting in waterlines shortly, they plan to start building mid to late June. We should reach our fifty (50) new homes before the end of the year.
 - He updated Council on other developments on the calendar and will provide more at a later date.

As a caution, there was a crew working out off of SR505 flagging traffic illegally for what they were doing, that got our sewer contractor into some hot water, although not their fault or responsibility. So, if you ever see something like this, please report it.

11. Agenda

a) Stop Sign NW Washington & NW Benton – Ryan Parmantier – Mr. Parmantier submitted a request asking that a stop sign be placed at Washington and Benton, that the current situation was an accident waiting to happen. Council discussed options and suggestion was made to make it a four (4) way stop; however, Councilor Poirrier pointed out that anyone coming down the Washington hill in inclement weather would have a difficult time stopping.

Further discussion led to Councilor Dowell stating that part of the issue was the poor set up the school district had made to pick up their children from school and the traffic backup it created, and stated he wanted the school's traffic off the streets. Further discussion bantered back and forth with the Mayor asking the Council what they wanted him to do, and he'd do it.

Councilor Dowell moved to have the Mayor discuss with the Superintendent of Schools to change their pickup process to eliminate the traffic, motion died for a lack of a second.

After the motion failed, Councilor Poirrier said that he would contact the School Board to let them know of our concerns.

Further discussion ensued regarding the stop sign. Councilor Poirrier moved to make Washington and Benton a 3-way stop and to place an additional stop sign on the northeast

corner of Washington and Benton, seconded by Councilor Allman, motion passed with majority vote, Councilor Dowell opposed.

His preference would be to give notice and allow vendors to set up and stay opened. *Councilor Dowell moved to approve the closure of Front and First streets between Walnut and Fir, seconded by Councilor Allman, motion passed unanimously.*
