- 1) UPDATE ON SEPA DNA-COLEMAN BOAT & RV STORAGE SEPA FOR COLEMAN BOAT & RV STORAGE (PARCEL No. 015638007007)
- 1. Mayor Svenson opened the Public Hearing at 6:00 pm.

Planning Commissioner Robert Webster was present to answer questions.

## 2. Public Comment -

- Terry Andrus shared concerns on whether Coleman Boat & RV Storage infrastructure will be (100) one-hundred-foot easement from the well. He also has concerns that motor homes and boats leak contaminated fluid and will contaminate the well.
- Sandi Andrus shared her thoughts on Coleman property. Ms. Andrus concerns are that a stream runs through the Coleman property, and hazardous contamination may leak from vehicles.
- Tim Fife expressed concerns for having A (100 ft. ) one-hundred-foot easement from the well. Mr. Fife asked Council for an update about speed bumps for Cowlitz and Cemetery Rd.

There was no one on the phone who wished to speak at this time.

Mayor Svenson informed the public that Coleman Boat & RV Storage will not be building within (100 Ft.) one hundred feet of the well. We do not want to see the water contaminated in any such way. We all share the same aquafer, and as far as vehicles may be, we can look into requiring drip pans.

Robert Webster informed Council Members and the public that the critical area is (50 Ft.) fifty feet for high density. In regard to the stream that runs through Coleman property Fish and Wildlife stated that there is not a stream or creek, it's a (50 Ft.) fifty-foot buffer. We are waiting for Zack Meyers from Ecology to respond. The grading work will have to flow to the storm water pond. There should be less water in the ditch than before.
