Council discussed filling the position. Mayor Svenson said that it must be filled within ninety (90) days, otherwise it lands on the commissioners to find someone to fill it. That would land on October 11, and election day is on the 2<sup>nd</sup> of November so there would be twenty (20) days in there that would be kind of a void. Essentially, that would be appointing someone for three (3) meetings, maybe four (4) if they do it quick. They must advertise for it and Svenson would like to do it quickly. Council member Dowell said that if they reach out to Lindsey (who was the only one who put her name on the ballot for council position #5) and ask if she wanted to come in fill in if it was legal to do so. City attorney Marissa Jay reminded that they do still have to advertise. Council decided that it would be best to just follow the processes. The advertisement would not

go out until the following week, but they could do that, and interview and appoint on the 23<sup>rd</sup> of August. This will only be until the election is certified at which time the winner of the election would take the seat.

Other businesses are getting involved. This would be part of NE First and Front Street. This would be a similar thing to Egg Day. This would be on a Saturday. The show would begin at Noon and go until later into the evening with no hard closing time but will slowly close down, and in as people leave. Mayor Svenson said that he would personally like to see more people come into town for events like this and applauds Amy on the idea. Council member Poirrier asks what other businesses Amy has talked with about this. Amy says that she has talked with Sahara Pizza who said they would close but are not opposed to that. Inspirations Hair Salon will be doing a 50-style hair pinup event for women. The Barber and his Daughter will be doing something, The Club will be doing a small street dance, Franks Bar also plans on something as well. The Saturday Market will benefit from the influx of people. Mayor Svenson thought the only issue might be the post office trucks needing to get in and out. Amy stated that they use a back-alley location to load and leave. Council member Poirrier tells Amy that he is glad to see people in the community doing something like this and that he approves. He makes a motion.

#### d. Rodney Cecil – Updates and Funds Request

Rodney addresses council on his updates and request. He needs to buy a new meter out at Cardinal Glass. It no longer reads and needs to be replaced. The cost is \$3,284 including tax. Parts are also needed because the lay length is 19" and the meter lay length is 14". Extra extending is needed. Council member Dowell mentions that the city has not accepted the off-site of anything for Cardinal Glass until they reimburse the city.

Rodney's update is about an issue with one of the wells producing air in the line. There are several ways to correct the issue. It is a fifty-five (55) foot deep well. Some of the options are, pay to have it drilled deeper, which would cost quite a bit of money. Another option is transferring some water rights from the eureka 1 well to the other well. It does have the capacity to pump the extra water. Rodney says that he will be coming back at some point with a plan of action.

Before moving on, Council member Dowell asks Mayor Svenson to elaborate on the rate study that he mentioned some time before. Mayor Svenson says that it is being looked at. It is not required just yet but in the next couple of years it will be. Currently though, it is being offered for free and Svenson wanted to take advantage of that because in the future, when getting grants, that will be looked at to make sure a correct amount is being charged for water and sewer rates. He hopes they will not say that the city needs to be charging more.

#### e. Accepting LE & CJ One-Time Funds SB5092 Funds for Law Enforcement & Criminal Justice

Mayor Svenson goes over the current situation where the hands of the officers are now tied when it comes to making drug related arrests. This is regarding the new laws about what officers now cannot do when finding drugs on people. The city of Winlock is being offered \$6,023.00 to "make up" for that. Svenson says that it can be put to good use and thinks it would be good to accept.
