### 5. Old Business

Council member Jeramy Allman asks where the progress is at with getting tree bids. Mayor Svenson replied saying that he still needs to get a hold of someone to walk that property to do the tree bids.

### 6. Mayor Comments

Mayor Svenson said that they did the Nevil Rd. repair. The state came out and helped. The county did not do much. The state used their dump trucks to haul out all the old asphalt and dirt that was pulled out. The state also used their trucks to run to the quarry and get more rocks. They also got onto the backhoe for a while and helped. Svenson stated a thank you to Washington DOT for the help.

DOT did say, that likely there would be an issue with the sink hole again in the future. Svenson said its one of those things that until there is the money to do it the right way, this is the route the city will have to take. Svenson said that he did already apply for that money; however, along with some other things. Svenson hopes that it will hold up until the money to do it right comes in.

The sewage pumping station has been paved and a new fence put around it.

The city has been getting a lot of emails and phone calls, and some have stopped into Winlock in person about the proclamation (from last council meeting regarding Washington State Governor Jay

Inslee) Svenson says that many people have voiced that they want to move to Winlock now. They have been coming to town going to our restaurants and checking out the town. Svenson said that out of 10-15 emails there have only been two (2) negative ones. Overall, people across the state have been supportive in taking that stance.

#### a. Grants – Contreras and Dowell

Jeramy Allman says that they went over things on Wednesday with Penny Jo, and everything is looking good and tracking well. There are still good receipts coming in for permitting. Allman asks Poirrier if he would like him to add anything. Poirrier says that he covered everything.

#### c. Parks – Alvord

Lindsey Alvord read the park update sent to her by Kirsten.

"The Park Board met on August 9<sup>th</sup> at Winolequa park. There had been a public input invitation advertised weeks prior, inviting the community to attend the meeting for the purpose of giving input on what individuals would like to see added or changed in the park over the coming years. Any input from the public is something the park board plans to keep in mind in the future as we plan for grants. No one from the community attended that meeting, but Mayor Brandon Svenson and Winlock councilman Marty Poirrier were in attendance. Marty was there to represent Winlock Youth Sports and the parents of children in youth sports. He relayed to the park board how badly the fields need repaired and has explained the that they are close to being unplayable with the amount of mole holes throughout both fields. Since that meeting, the park board has shifted its focus to the fields and at this time, the fields will likely be the first area of Winolequa Park to be worked on when grant money is obtained. In the meantime, discussion of volunteer days to fill holes and create a drainage ditch to keep the fields playable is on the table for discussion. This is something that can be done to help the situation until a contractor can be hired.

The board has been in contact with Kim Sellers, a grant manager from RCO (Recreation and Conservation Office.) She will be meeting with the members in person on Wednesday September 2<sup>nd</sup>, to view parks and further help with the preparations for the grant processes. Winlock City Council members are welcome to attend.

The next meeting is on September 6, 10:00 am at Winolegua Park."

## b. Recommendation of Award for 2021 Water System Improvement Project Gray and Osborne

John Hinton with Gray and Osborne had called in and addressed the council. On September 21<sup>st</sup> they had 6 bids come in for the 2021 water system improvement project. They range from just shy of \$495,000 to all the way up to \$728,000. Jon Hinton recommends the award to Midway Underground in the amount of \$494,952.92 contingent on the completion of the environmental review processes.

They were the ones who did the work on Mickelson Parkway. New letters to the tribes were sent out about 35 days ago and so far, there have been no comments back, so they updated the check list, and the mayor has signed that this afternoon. It has been sent to CBDG and the department of historical preservation. Hinton says his assumption is that they should be getting a final approval letter from them within the next two weeks. Hinton asks if there are any questions. There were none, but council member Allman thanked John Hinton for reminding him that they were the ones who did the work out on Mickelson Parkway.

### Mayor Svenson entertains a motion to accept the award to Midway Underground.

#### c. Cedar Court Nuisances

Mayor Svenson says that this is not an action item. He believes that Robert Webster just wanted to bring these things to attention. Robert is the new code enforcement officer for the city. Svenson believes that everyone has read Robert's letter citing these things. Everyone has read it but only a few council members have seen it themselves. These are things like homes with multiple cars on the street and an RV which makes it impossible to use the road correctly, garbage strewn in front of another home, another home with car parts, garbage, and junked cars all over, and more. Svenson stated that over the last year, multiple letters have been sent out to the residents which has by now given ample time to start cleaning up. Svenson says that most people have been cleaning up but there are still a few who have not. Svenson asks if anyone has any questions regarding this before moving on. So far, all the actions taken have been warnings, but no fines have been given. Svenson is trying to avoid fines. There were no further comments or questions.

### d. Payment Plan Solutions – Outstanding Water/Sewer Accounts

Mayor Svenson says/asks from what he understands, nothing can be done until January 1. Council member Allman says kind of. No shots can be given, but payment plans can be sent out on the next bill. Penny Jo stated that she has a plan to send out plans to individuals who still owe. Haney says that she believes that after 30 days of sending notice, the city can start enforcing. Haney asks city attorney Marissa Jay if this is correct. Marissa confirmed. Svenson stated that what actions to be taken will be up to the council. Haney mentioned that in a lot of the literature that she has been reading in MRSC that there is a lot of encouragement to extend this out for another year. Council member Alvord asks

if there is a number on how many people are behind. Haney says that there are 13 who are severally behind, but most folks are making the effort to get caught up and are not as far behind. Alvord said that in a search that she did, she saw roughly 30 different programs that help with water. Contreras added that there are programs that help with housing as well. Haney says that she would like to put together a one resource for people. She has received one such page that she will print out.

Svenson asked if the payment plan was open ended, and if not what ending date was discussed. The council could not recall. Marissa Jay said that people must enter a payment plan before January 1, or February 1. She could not remember the exact date but did say that they had to enter into a plan before the date.

Council member Allman said that he would love to hear what some of the neighboring cities are doing about this. Council member Poirrier asks if writing the bills off for people would be gifting of funds to which Marissa confirmed that yes, it would be and so that is not an option.

Haney said that the next step would be going to collections. Poirrier stated that he likes the plan of sending people notice with options and a resource list and then if they have not started to pay off their bills by January 1<sup>st</sup>, to then proceed on acting. Poirrier asks how the council feels on that idea. The council generally agreed. Mayor Svenson asks if there is any further discussion. There was none.

Mayor Svenson entertains a motion to extend the payment program.

Contreras talked about how in Cedar Court there no speed limit and people drive through there fast which is concerning because of the children that live there. With the new development coming in next to cedar court it would be even better to put a limit in

along with some speed bump if possible. The council continued discussing. Svenson said this could be for future developments or for both future and current.
