 - (2) IFC Section 907.2, system installation, is amended by addition of the following section: 907.2.24 system installation. Fire alarm systems shall be intalled and maintained in accordane with this code by persons under the direct supervision of individials that have facotry training and certification on the system being installed.
 - Plans submitted for Fire Alarm System Permits shall be prepared under the supervision of individuals possessing a NICET (National Institute for Certification in Engineering Technologies) Level III Certification in Fire Alarm Systems; or shall be licensed by the State of Washington as a Professional Fire Protectioin or Electrical Engineer or certified by the State of Washington. Plans shall identify certification and/or licensing information.
