City Council Meeting February 12, 2024

CALL TO ORDER

a. Stephen Valentine, Police Chief

Mayor Svenson read Chief Valentines monthly call activity report. There were (89) Eighty-nine monthly and year to date.

b. Penny jo Haney, City Clerk

Penny Jo has had people inquiring about the cost of public records request. She provided a 4-Year look at Public Records Requests from 2021-2024. Penny Jo read her report for the record. The report included a breakdown of requests, total hours to produce documentation, total cost to produce documentation, average cost per request, total revenue, and taxpayers cost. This report does not include Court and Police Departments. Taxpayers cost 2024 current to 2-5-24 (-\$4,122.90). Mayer Svenson said in situations you have one person asking for a specific item, in other circumstances you have a handful of people that ask all Cities for frivolous information that cost thousands of dollars. Council member, Bowers asked if there is anything the City can do to protect from the frivolous requests. Mayor Svenson replied "no there is not". City Clerk, Penny Jo said she is not opposed to Public Records request. She just wanted to inform the Council and the Citizens of Winlock of the current cost.

9. Public Comment -

Marty Poirrier- Mr. Poirrier commented that he is here to talk about the language in the Animal Ordinance draft. There are things that are not in there that he has asked for. Mr. Poirrier hopes that this is simply a draft for the Council to look at and discuss and not pass this Ordinance tonight. City Clerk, Penny Jo said that she did include a watermark of "draft" on the document, but the draft did not come through during copying. Mr. Poirrier said he was asked at the last meeting, what stops any other Council from coming in and changing the law? Mr. Poirrier answered, nothing. Mr. Poirrier said he was wrong the Council and Citizens are the ones who keep that from allowing that to happen.

Debbie Dwelly – Miss Dwelly said that she is glad to hear that the Animal Ordinance is an unfinished draft. Miss Dwelly would like to be part of reviewing the draft, deciding on the changes. There is language she would like to change. Miss Dwelly also has concerns in regard to being able to carry a firearm in the need if putting down an animal without having Police aid.

Patty Maninfior- Miss Maninfior, brought to the Council attention that having zoom available is great, but at times the audio is hard to hear.

Kathy Chastain, Via zoom – Miss Chastain said she was happy to see the Council discussing the Animal Ordinance draft. Miss Chastain also commented that the Meyers Meadow sign looks (Ghetto) and is hoping it can look a little more professional.
