- a. Edna Fund Southwest Washington Fair (SWWF) Update Edna Complimented City Clerk, Penny Jo for her organization and fast response. Edna introduced the first Lewis County team teen, Capri O'Neill. Edna said that they are on the road advocating for the Lewis County Fair. They're offering free admission into the 2024 Southwest Washington Fair August 13,2024 before 11:00 a.m. Edna also would like to see more people get involved by showing art or other interest they might have.
- b. Baitchell Well Emergency Fund Request, Rodney Cecil Rodney said the pump went offline and stopped pumping water into the system. Skyline Pumps pulled the pump. There was an electrical problem. We ordered a new pump and motor, and Skyline was onsite to install the required equipment. Rodney included the invoice for twelve thousand, seventeen dollars and fifty-four cents (\$12,017.54) that will come out of the existing Capital Improvement fund that is in the budget this year. Screw Press Scope of Work Agreement, Rodney Cecil Rodney stated that Ecology approved two hundred twenty thousand, nine hundred and eighty dollars (\$220,980.00) that is for the screw press, and planning design. Half of that is free money, the other half we will have to take a loan out for .06%. The loan will not go into effect for close to a year after the project is complete. We have to start paying that back in about two (2) years down the road. Rodney said as soon as we go to Ecology with a design, they will sign off on it. - f. Grant.Gov-Removal, Replacement and Restoration Grant- City Clerk, Penny Jo said that we do have a Grant writer, Amy Buzzard, that we retained months ago. Penny Jo said we applied close to a year ago for Federal dollars to get the RAISE grant for the sink hole replaced, but we didn't get any grant funding. Penny Jo said that she spoke with Amy, and that Amy sat in on an online seminar on May 15th, and we can apply for a Culvert Grant. The Current Closing Date is September 23,2024. They would fund eighty percent (80%) and we would fund twenty percent (20%). Penny Jo said that the Tribals receive hundred percent (100%) funding. Penny Jo said we can use the Impact fees since the culvert would be new. Penny Jo said that we are looking into other match options as well.

g. TextMyGov 24/7 Citizen Notice & Alert System -Water/Sewer Superintendent, Rodney said this is a way to allow us to communicate general information when we have water leaks, and other city notices. Rodney and the Council discussed the budget, and determined we would not pursue at this time.
