4. MAYOR COMMENTS

Mayor Svenson said Military Road is looking great and is very happy with the work out there. They have been communicating great with Robert and his self. The work is being done well, moving along quickly, but with quality. Mayor Svenson said its looking good and should last a long time. Mayor, Svenson said that the fence at the high school ended up being in the right of way where the fire hydrants will go and the footing for the fire hydrants. 7. Reports

Community Development, Robert Webster — Robert said Mindi and himself have been effective and productive reviewing permits and assisting people quickly as possible. Robert moved on to say, we are currently sitting on Forty-seven homes and currently working on another four, four plex unit permits, hopefully we will get them in by the end of the year. Robert provided Mayor, Svenson and the council with a report of development updates. Robert said Grant Ave should start in the spring. Robert and the council had a short discussion on a few of the development projects.

Mayor, Svenson expressed appreciation to Robert for everything he does here. Mayor, Svenson said we are the third largest city in the county working with a one-and-a-half-man crew and Robert has taken on the Better half of this as a one-man band and the next biggest city is Chehalis with a four-person community development department and hiring a Community Director. 11. AGENDA

- a. HOA Hearings & Covenants (Jay Vander Stoep) Discussion Jay introduced himself. Jay said he has been the City Hearing Examiner for about twenty years. Jay said in the last five years we had fifteen to twenty home sights here. Jay said some of the new sites are small they have small garages and small driveways and in about ten years from now and you have resident with junk in their yard that depreciates value and home equity value, multiply that by a lot and it effects the whole community. Jay said the covenants he provides we will be putting on to all the new developer so that it gives the neighbors a right to say hey. The convenance gives the city a right to do something about it. Jay suggested to have a Code Enforcement Officer could even be a citizen. Jay said having a mechanism now can help to preserve the beauty of this community, if you don't have a Code Enforcer this can have a huge effect on your community. Mayor, Svenson thanked Jay and asked about pushing for overflow parking in place of cramming more houses. Jay said the City can require the development to provide the overflow parking, but still risk parking RV etc.
- b. Ordinance 1177-2025 Budget Mayor Svenson reads. AN ORDINANCE OF THE CITY OF WINLOCK, WASHINGTON, ADOPTING THE ANNUAL BUDGET FOR THE CITY OF WINLOCK, WASHINGTON, FOR THE CALENDER YEAR 2025 AND PROVIDING FOR THE EFFECTIVE DATE HEREOF. Mayor, Svenson said promises were made and promises were kept. When we went into annexation, we said it was for revenue that the city would need in purity. Mayor Svenson said you can see it with other cities struggling, but the City of Winlock will not be struggling, in part of annexation and the money we were asking for is the same as it was last year, that means we did not raise the levy rates they are the same as last year. Mayor, Svenson moved onto say he said that they would lower taxes, but of when you get your taxes there are levies

involved, so could not guarantee that the overall bill would be lowered not knowing what the fire department or school was going to do. Mayor, Svenson moved onto say that the county is increasing property tax this year, not sure of the number it was point nine zero (.90 per thousand) but also the county charges a road tax for one point two zero (1.20 per thousand). When you live in the county you assume property tax at point nine zero (.90) and road tax at one point two zero (1.20). When your annexed into the city limits the road tax is at one point two (1.2) turns into the city levy at seven point three (7.3) and there is the reduction in taxes. Mayor, Svenson said even if we took the maximum amount allowed, we would been at one point one (1.1) which is still lower than what we were paying but would have increase the former citizens rates. Mayor, Svenson said everyone is raising taxes and the only city in this county that has lower taxes on the city citizens and would have lower taxes on the citizens of the UGA and is happy to say that the promise was kept, and the city is bringing in one hundred ninety-one thousand dollar (\$191,000.00) in tax with having while having them lower this year. *Council Member, Jeramy Allman Motioned to Approve Ordinance No. 1177 2025 Budget. Second, by Council Member Jess Bowers, the Motion passed unanimously.*
